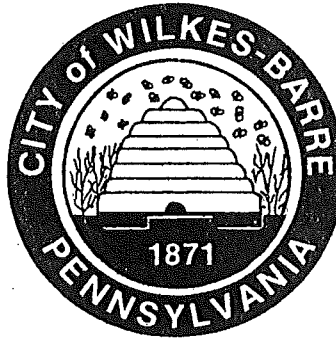

FILE OF COUNCIL NO. 2 OF 2011 – AN ORDINANCE OF THE COUNCIL OF THE CITY OF WILKES-BARRE, LUZERNE COUNTY, PENNSYLVANIA, SETTING FORTH ITS INTENT TO ISSUE A FEDERALLY TAXABLE GENERAL OBLIGATION BOND, SERIES A OF 2011 (THE "SERIES A BOND") AND A GENERAL OBLIGATION NOTE, SERIES B OF 2011 (THE "SERIES B NOTE", AND TOGETHER WITH THE SERIES A BOND, THE "BONDS), OF THE CITY IN THE AGGREGATE PRINCIPAL AMOUNT NOT TO EXCEED SIX MILLION DOLLARS (\$6,000,000) PURSUANT TO THE ACT OF THE GENERAL ASSEMBLY OF THE COMMONWEALTH OF PENNSYLVANIA, 53 PA.C.S.
